Instructions for Use

Follow these instructions to calculate the median income for a specific household:

1. Locate the county or metropolitan area where the household will reside.
2. Using the very low-income row, locate the amount underneath the column of the actual household size.
3. Multiply this amount by two. (This number represents 100 percent of the area median income.)
4. Multiply the result of Step 3 by the targeted percentage (i.e. 50%, 60%, or 80%).
