FORTIFIED Fund Rental Program

Disbursement Request Guide



Overview

The Federal Home Loan Bank of Dallas (FHLB Dallas) will provide grants to support the upgrade of existing roofs on affordable rental housing to FORTIFIED[™] Roofs. These roofs integrate research findings from the Insurance Institute of Business and Home Safety (IBHS) focusing on mitigating damage caused by severe weather events. Disbursement of funds will be made to FHLB Dallas Member Financial Institutions working in conjunction with a sponsoring Public Housing Authorities (PHAs). **Disbursements will be made to projects that have previously received commitments in the 2025 FORTIFIED Fund Rental Program application cycle.**

Disbursement requests must be submitted by the FHLB Dallas Member Financial Institution via email to FortifiedFund@fhlb.com.

Disbursement Process

Projects that have received a commitment and made appropriate preparations for roof replacement will then submit a request for disbursement. FHLB Dallas will review disbursement submission documentation. Upon approval, 70% of the committed funds will be disbursed to the submitting Member Institution. Once the roof replacement is complete, the FORTIFIED Certificate issued by IBHS must be submitted to FHLB Dallas. Upon review and verification, FHLB Dallas will notify the Member Institution of project completion and disburse the remaining 30% of committed funds.

Disbursements are anticipated to occur within 3 weeks of receipt of the request. This timeframe may be extended based on the completeness of the request and clarification response times.

Approval from IBHS

FORTIFIED Multifamily

The Insurance Institute of Business and Home Safety (IBHS) reviews key details for all projects obtaining FORTIFIED Multifamily certifications. Submission of information must be made here: https://focus.fortified.org/.

IBHS recommends submitting architectural, structural, and electrical drawings when completing the application form online using the above link. Other required documentation must be submitted, with the FORTIFIED Evaluator providing guidance on timing. For any questions relating to the FORTIFIED Process, please reach out to IBHS.

FHLB Dallas will only make disbursements after IBHS has issued their preliminary approval based on their review of submitted documentation.

FORTIFIED Home

IBHS does not have a pre-qualification approval process for structures that go through the FORTIFIED Home designation process. For properties going through this process, FHLB Dallas requires the sponsoring PHA to work with a certified FORTIFIED Evaluator. The Evaluator must visit the property(s) to verify that the structures are eligible to receive a FORTIFIED Roof through the FORTIFIED Home process. Once eligibility is confirmed, the evaluator must fill out the Pre-Construction Evaluation Affidavit. A template for the document can be found on the next page. If the project contains multiple buildings, each address must be listed on the document. Multiple forms can be submitted if there are more than 10 properties in the project.

Beginning November 1, 2025 IBHS will require contractors to be FORTIFIED certified for FORTIFIED Home designations. If the properties submitted as part of the application will receive a FORTIFIED Home certification, FHLB Dallas will require evidence of the contractor certification as part of the disbursement request.

FORTIFIED Fund Rental Program Certification

FORTIFIED Home Pre-Construction Evaluation Affidavit

This form must be completed only if the property is going through the FORTIFIED Home process. To qualify for the FHLB Dallas FORTIFIED Fund Rental Program grant, a FORTIFIED Evaluator must perform an initial review of each property's current condition and provide documentation of the steps needed to complete the roof. This affidavit must be submitted to the submitting Member Institution to satisfy the documentation requirements. The Member must provide this document in their disbursement request submitted to FHLB Dallas.

An Evaluator may sign off on up to 10 homes/affidavit if the evaluator is serving multiple homes in the same application.
