## ***Commitment to Service Members and Their Families***

The Housing Assistance for Veterans (HAVEN) program, through Federal Home Loan Bank of Dallas members, helps fund new construction, and improvements or modifications to homes of U.S. veterans and active-duty, reserve or national guard service members who became disabled as a result of their military service since August 2, 1990.

## ***More to Give***

HAVEN:

- Provides up to \$20,000 in grant funds per household
- Is open to all veterans or service members injured during military service since August 2, 1990
- Is open to Gold Star Families who lost a family member in service since August 2, 1990
- May be used to assist families at or below 165 percent of the area median income
- May be used for properties throughout the United States
- Requires no member contribution
- Is awarded on a first-come, first-served basis



## Rebuilding Lives

Examples of HAVEN uses:

- Modifying an existing home to meet the needs of a U.S. veteran or service member
- Offsetting construction costs of a newly constructed home
- Paying for a third-party inspection
- Down payment and closing-cost assistance for first-time homebuyers
